MINUTE OF CORONER B WINDLEY AS TO GENERAL INFORMATION DISCLOSURE NO. 2

Information disclosure background and approach

- [1] The Minute on General Information Disclosure No. 1 (General Information Disclosure Minute No. 1) of 8 March 2022 set out the background and approach to information disclosure. As part of that disclosure, a number of documents were sent to Interested Parties or to their counsel, including:¹
 - (a) the First Response Timeline, prepared by the New Zealand Police; and
 - (b) a response by Canterbury District Health Board's (CDHB) to a notice to supply information, pursuant to s 120 of the Coroners Act 2006 (Coroners Act).

- [2] At paragraph [14] of the General Information Disclosure Minute No. 1, it was noted that material underlying the CDHB's written response to the s 120 notice was still to be provided by CDHB but would be disclosed once received.
- [3] The same approach adopted to disclosure associated with General Information Disclosure Minute No. 1 will apply to this second general disclosure, namely:
 - (a) The information will be provided to all counsel and unrepresented organisations with Interested Party status without the need for a further information request.
 - (b) The same information will be available to people who are unrepresented Interested Parties but on request only. People who are unrepresented Interested Parties can request the information outlined in this Minute by directing a request by email to coronial.response@justice.govt.nz.
 - (c) The information disclosed is not intended as a substitute for an inquest bundle which will be prepared in the usual way in due course.

- (b) the underlying source material to CDHB's response, consisting of:
 - i. August 2018 Major Incident Plan which was in place at the time of the 15 March 2019 attack;
 - ii. 26 June 2019 memorandum to the CDHB Health Emergency Governance Group attaching
 - the Feedback Summary;
 - a draft action plan for managing the opportunities for improvement identified in the feedback;
 - iii. 8 October 2019 Major Incident Plan update for Chiefs and Chairs dated; and
 - iv. 25 March 2022 cover letter from CDHB's counsel which includes additional information.
- [5] This information was obtained for the purposes of this inquiry in response to notices to supply information pursuant to s 120 of the Coroners Act. As such, the information is subject to the express limitations on use afforded under s 127.

No further dissemination of disclosure and s 74 interim non-publication order

- [6] As previously stated in the General Information Disclosure Minute No. 1, Interested Parties who receive disclosure as part of the coronial inquiry must not provide a copy of, or access to, the disclosure to anyone who is not an Interested Party (other than instructed counsel).
- [7] The information disclosed in association with this Minute details the medical and emergency response to the 15 March 2019 masjidain attack or the names and/or identifying particulars of the people involved relates to the first response. Consequently, the interim non-publication orders of 8 March 2022 apply. Publication is prohibited on interests of justice grounds as set out in that order.
